Legacy Treatment Services is one of New Jersey's largest behavioral health providers, dedicated to improving lives through a comprehensive range of programs and services. Their mission is to change the behavioral health and social service outcomes for individuals of all ages from surviving to thriving. While located in all 21 counties of New Jersey, Legacy's roots formed in Burlington County, and they maintain a significant presence within the county. Legacy Treatment Services donated funds will support an enhanced extracurricular and career readiness program at their Children's Home Campus and Mary A. Dobbins Special Education School. The Children's Home Campus of Mount Holly is an integral part of their mission, serving over 100 children and youth, ages 10-19, who face a spectrum of emotional, mental, and behavioral health challenges.

Tarnsfield Swim Club is a family-centered club, welcoming families from Westampton and the surrounding communities. As a non-profit organization owned by Westampton Township, Tarnsfield Swim Club relies entirely on membership fees to cover the salaries of their managers, coaches, and lifeguards, as well as the general upkeep of their facilities. However, at over 40 years old, Tarnsfield Swim Club needs significant upgrades to operate safely and efficiently. The donated funds will be used to upgrade amenities at the pool area including the purchase of a Dolphin Wave Vacuum.

The Spellbound Century ride has become the *biggest independent cycling event* of the summer with over 10,000 participants in ten years. The Century has historically sold out every year months in advance of the event date and it has raised \$500,000 for various non-profit organizations in the Rancocas Valley region. Additionally, the event has also promoted Burlington County, Mount Holly Township, local businesses, and *Jersey Fresh* by attracting participants from over 23 states and staging rest stops along the way at local farm markets where participants can purchase fresh goods that are transported by volunteers to the finish line for pick-up.
